John Shoven

Charles R. Schwab Professor of Economics, Stanford The Trione Director of SIEPR Buzz and Barbara McCoy Senior Fellow of the Hoover Institution Masaaki Shirakawa was the Governor of The Bank of Japan from 2008-2013, and as such shaped the monetary policy of the world's third largest economy during the global financial crisis. He currently serves as Senior Advisor and member of the Global Advisory Board at Promontory Financial Group. In addition, he is a Special Professor of International Politics, Economics and Communication at Aoyama Gakuin University. Mr. Shirakawa graduated from The University of Tokyo with a Bachelor of Arts in Economics, and he holds an MA in Economics from the University of Chicago.

Stephen Mayfield is director of the California Center for Algae Biotechnology, and a Co-director of the Food and Fuel for the 21st Century organized research unit at UC San Diego. He is also the John Doves Isaacs Chair of Natural Philosophy in the department of Biology. Following a post-doctoral fellowship at the University of Geneva Switzerland he returned to California as an assistant professor at the Scripps Research Institute where he remained for 22 years becoming the Associate Dean of Biology before joining UC San Diego in 2009.

Ken Kroner, PhD, Senior Managing Director, is global head of Multi-Asset Strategies as well as head and Chief Investment Officer of Scientific Active Equity at BlackRock. Dr. Kroner's service with the firm dates back to 1994, including his years with Barclays Global Investors (BGI), which merged with BlackRock in 2009. Prior to joining BGI in 1994, Dr. Kroner was an associate professor of economics and finance at the University of Arizona. Dr. Kroner earned a BA degree in mathematics and economics from the University of Alberta in 1983 and a PhD in economics from UC San Diego in 1988.

John Shoven's recent work has been in the field of economic demography. He has written extensively on Social Security, including a number of papers on the advantage of deferring the commencement of Social Security benefits beyond retirement. Over the years, he has written more than one hundred professional articles and has authored or edited more than twenty books. He is a recipient of the Paul A. Samuelson Award for Outstanding Scholarly Writing on Lifelong Financial Security. John Shoven graduated from UCSD in 1969 majoring in Physics. He then went to Yale to study economics. He has been on the Stanford faculty ever since receiving his PhD from Yale in 1973.
